



Financial Assistance to families call for Applications 2017 Pau Gasol Academy by Popular 2017

These Rules are intended to establish the conditions for the grant of financial assistance to families with underage children and are directed to pay the costs of registration and participation in the Pau Gasol Academy to be held in late June 2016 in Barcelona.

BENEFICIARIES

The parent, guardian or person(s), bearing the custody and legal custody or are in the process of getting legal guardianship of those minors aged between 12 and 18 years at the time of application.

ECONOMIC AMOUNT

Once all the applications that meet the requirements are certified the granting of assistance shall be granted for an amount of 100% or 50% of the total cost of the activity.

CRITERIA FOR THE GRANTING OF AID

1) ECONOMIC INCOME:

It will be taken into account the per capita income of the family unit to which the applicant belongs. For granting the aid it shall be taken as a reference the valid IPREM (IPREM 2017 Annual 14 payments: € 7.455,14). In no case the per capita income may exceed 10,000 €.

¹It is understood per household: In case of marriage: Integrated by spouses not legally separated and, if there's any children under 18, except that, with the consent of parents, live independently of these, and the older children subject to judicial custody extended or rehabilitated; In the absence of marriage or legal separation: The formed by the parent and all the children that live together and meet the requirements stated above for the 1st mode.

The Public Multiple Effect Income Indicator (IPREM) is an index used in Spain as a reference for the granting of aid, scholarships, grants or unemployment benefits among others. This index was created in 2004 to replace the minimum wage as a reference for these aids.

2) NUMBER OF CHILDREN IN THE FAMILY:

All children with 18 years old or less in the household will be counted, given the date of the application. In the case of expectant mothers, it will also count as a minor.

3) EMPLOYMENT STATUS OF THE HOUSEHOLD RESPONSIBLE(S)

Unpaid unemployment of those responsible for the household.

4) NUMBER OF DISABLED AND / OR SICK IN THE HOUSEHOLD:

Each member of the family unit with disabilities, who has the legal status of disabled and has been recognized as such in the manner provided in the Royal Decree 1997/99 of 23 December on the procedure for recognition, declaration and qualification of the degree of disability.

5) MINOR'S ACADEMIC RESULTS:

For granting financial aid, it will be considered adequate academic performance of the child.

DOCUMENTATION:

To apply for this financial support, it will be necessary to submit the following documents:

- Complete online form
- Photocopy of DNI, NIE or passport.
- Photocopies of the last income statement or documents of income of the members of the family unit.
- Photocopy of the family book.
